### **EXTENDED DISCLOSURE**

This information provides detailed information on cookies and other tracking tools, how they are used by Tomorrow Tech Srl (hereinafter also referred to as the "Data Controller"), and how to manage them, pursuant to art. 13 of Regulation (EU) 2016/679.

In the course of the following information, the use of the term cookie must also be understood as extended to any tracking tools used by the Site.

This information is an integral part of our [Privacy Policy](#) and is provided only for this \_\_\_\_\_ site (hereinafter also the "Site") and for its possible subdomains and not for other websites that may be consulted through any links.

This cookie policy is an integral part of the information on the processing of personal data on the Site.

#### **1) WHAT ARE COOKIES?**

Cookies are usually text strings that websites (so-called "cookies"). Publishers, or "first parties") visited by the user or different sites or web servers (so-called "first parties"). "third parties") place and store within a terminal device at the disposal of the user, such as, for example, a computer, a tablet, a smartphone, or any other device capable of storing information.

The information encoded in cookies may include personal data, such as an IP address, username, unique identifier, or email address, but may also contain non-personal data, such as language settings or information about the type of device a person is using to browse the site.

Cookies can generally be divided into two main categories:

- a) **technical cookies**, used for the sole purpose of *"carrying out the transmission of a communication on an electronic communications network, or to the extent strictly necessary for the provider of an information society service explicitly requested by the contractor or user to provide such a service"* (cf. Section 122, paragraph 1 of the Code); Analytical cookies are used for statistical purposes and are assimilated to technical cookies where, under certain conditions, they are used to produce aggregate statistics in relation to a single site or a single mobile application; otherwise, analytical cookies require the user's consent for their use;
- b) **profiling cookies**, designed to associate specific actions or behavioural patterns of the user recurring in the use of the functions offered in order to create a specific profile to be used for

the provision of a service in an increasingly personalized way, as well as to send advertising messages in line with the preferences expressed by the user in the context of web browsing. In addition, all cookies can also be categorized as:

- **session cookies**, if they are deleted when the browser is closed, or
- **persistent cookies**, if they remain in your browser for a certain period of time.

Similar purposes can also be pursued through other tracking tools, which – like cookies – can be divided into technical and non-technical tools (generally of a commercial or promotional nature).
